The Lorain County Board of Mental Health plans, funds, and monitors a system of quality public mental health services that enhance the health and well-being of the people of Lorain County.

A citizen Board of 18 community members determines services to be provided and funded based on state requirements and community needs. Board members monitor funding and evaluation of public services. Private, not-for-profit, and independent agencies are contracted by the Lorain County Board of Mental Health to provide an array of mental health services. Services include counseling, psychiatry, prevention, peer-to-peer support, crisis intervention, housing, as well as consultation, and community and vocational support.

This is the Board's 50th year of serving the community.

9,382 Adults

In Fiscal Year 2018, our mental health network served 9,382 adults. Though we cannot calculate the number of neighbors, family members, friends, and loved ones who made that care even more successful, we appreciate your efforts each day.

3,228 Children

In 2018, our mental health network served 3,228 children, inside and outside of school. School personnel at all levels, plus parents and neighbors, are recognizing the importance of mental health for our youngsters, and taking action to learn how to help.

18,071 Crisis Calls

Our 24/7 Mental Health Crisis Hotline took 18,071 calls, for intervention, or to provide advice or connections to peer support. Crisis Text Line received 353 texts from Lorain County. Our Navigator took 715 calls to connect residents to their best and most readily available mental health service option.

En 2018, realizamos un número récord de simpatizantes que votaron por apoyar la atención de salud mental, participaron en clases y en eventos, y conectaron a sus seres queridos con la atención necesaria. Gracias por participar en la atención de salud mental y por ayudar a proporcionar un futuro alegre y estable para los residentes del Condado de Lorain.

Este año, la LCBMH atendió a 9,382 adultos y 3,228 niños. Nosotros respondimos a 18,071 llamadas telefónicas de emergencia. Enseñamos clases para 753 residentes y 971 profesionales, y la gente votó "¡Sí!" por el impuesto a la salud mental.

Counts may include some duplication. For example, the same person might have attended both a Mental Health First Aid class, and a suicide prevention class, and was counted twice, or called the hotline multiple times. We strive for unduplicated counts whenever possible. Also, numbers may be rounded or estimated or missing some unknown information, and may not always equal 100%.

We celebrate 50 years of serving the community

50 years ago, nine people gathered in an office on Broad Street in Elyria, Ohio, to commence a local mental health system. The meeting took less than an hour, but launched a public mental health network that now serves thousands of adults and children each year.

Our Board of Mental Health began in Fiscal Year 1968, enacted by legislation on October 26, 1967, with that first face-to-face local meeting on June 3, 1968. This year, we celebrate our 50th anniversary of serving the residents of Lorain County.



257 Hours of Professional Development

Clinical staff, as well as law enforcement and school staff, benefit from our professional trainings. In 2018, we reached 971 professionals.



147 Hours of Community Education

We offer suicide prevention education, as well as Mental Health First Aid, for any interested community member. In 2018, 753 residents took advantage of free educational classes or events.



Voter Support

Voters in the May 2018 election in Lorain County supported the mental health care levy with a 74.4% approval rating. That number is unprecedented in our Board history and surpasses the approval ratings of other similar levies statewide.



"The millisecond my hands hit the rail, it was an instant regret."

Kevin Hines chose to live—one moment too late. He attempted to take his own life by jumping from the Golden Gate Bridge. He survived. Now, he is a leading suicide prevention advocate and powerful speaker on mental wellness.


